1. 제안 배경

- 건강불평등, 건강의 사회적 결정요인에 대한 역학적 분석과 정책/전략을 함께 다루며 과학적 지식의 정치성과 현실 적용 문제를 지속적으로 고민해왔던 서리풀 사회역학-정책 협동 세미나가 11번째 시즌을 맞았습니다.
- 2019년에 진행할 11기 세미나의 주제는 **‘사회정책의 건강불평등 영향’**입니다. 건강불평등을 완화하려면 보건의료정책을 넘어 건강결정요인에 대한 ‘사회적 접근’이 필요합니다. 하지만 대부분의 사회정책이 설계나 실행단계에서 건강불평등을 특별히 염두에 두지 않고, 그러다보니 건강불평등 영향에 대한 평가연구도 잘 이루어지지 않습니다. 이는 정책 효과 평가를 둘러싼 연구방법론의 도전이자, 건강의 사회적 결정요인 개입을 둘러싼 정치성의 문제이기도 합니다. 이번 세미나에서는 주요 사회정책들이 건강불평등에 미치는 영향을 분석한 실증 연구들을 함께 검토하고 한국 사회에의 적용가능성을 탐색해보고자 합니다.
- 서리풀 토요세미나는 모두의 협업과 토론으로 진행되는 자율적 공부모임입니다. 학습의 필요성에 공감하고, 연구를 통한 실천 활동에 동참하고자 하는 젊은 연구자, 학생들의 성실하고 자발적인 참여를 제안합니다.
